In 2012, Laboratoires Théa launched the first Théa interRnational contest of clinical cases in PatHologies of the eYe: TROPHY.

TROPHY is a yearly contest, designed to encourage residents and fellows in ophthalmology to play an active role by sharing the findings of their case studies and their experience. Contestants submit a clinical case they were involved in and which is original from a scientific standpoint. The clinical cases shall be related to a different pathology each year.

The jury will grade the clinical cases according to the following criteria:

- Clarity
- Originality
- Quality of illustrations
- Contribution to ophthalmological knowledge

INTERNATIONAL FINAL JANUARY 2017



In early January the best case from each country will be submitted to an **international jury of experts** that will decide the **three winners** of the 2016-2017 TROPHY Contest.



The authors of the three best cases will be invited to present their work at Théa symposium during the prestigious ARVO 2017 meeting in Baltimore, USA (travel, registration and accommodation paid for by Théa). This symposium will be a great opportunity to share the stage with highly recognized experts in front of an international audience.

Théa will also edit a brochure with all the best national cases.



The contest is open to **all residents or fellows** in ophthalmology from the following countries: Algeria, Austria, Belgium, Croatia, Czech Republic, Denmark, Finland, France, Germany, Greece, Ireland, Italy, Luxemburg, The Netherlands, Mexico, Morocco, Norway, Poland, Portugal, Romania, Russia, Slovenia, Spain, Sweden, Switzerland, Tunisia, Turkey, United Kingdom, Ukraine.
